Significant ridership and fare revenue declines due to the coronavirus pandemic, as most Californians responsibly shelter in place, threaten the viability and availability of transit services in the near- and long-term.

Nonpartisan Legislative Analyst's Office details challenges facing public transit agencies

- The nonpartisan Legislative Analyst's Office (LAO), which advises the California State Legislature on all policy and funding matters, recently analyzed the impacts of the federal CARES Act on public transit agencies and discussed the future challenges that lie ahead.
- The analysis covers the steep revenue and ridership declines transit agencies are experiencing now, acknowledges that the CARES Act provides temporary relief, and that it will be a challenge to convince riders that transit is safe once the shelter in place order is lifted.
- "If the losses in revenues are greater than the amount the CARES Act provides transit agencies, **transit agencies might have to make significant reductions in costs, such as delaying capital projects and permanently closing certain routes, stations, and services.**"

Failure of transit agencies will disproportionately impact low-income riders

- Stockton University economics professor Ramya Vijaya recently published an article discussing the disproportionate impact of transit system service reductions on the large proportion of low-income households that depend on buses and trains to get to work and elsewhere.
- About 20% of the poorest households don't own a vehicle, making them entirely reliant on public transportation.
- Limitations in transit services in certain regions of the country also lead to higher unemployment rates and longer durations of joblessness.
- If cities and states have to drastically cut back public transportation availability over the long term, it could exacerbate these inequities.

Bay Area transit agencies coping with impacts of coronavirus

- Despite ridership declines of 90%, Bay Area transit agencies continue to transport travelers consisting mostly of essential workers every day.
- To avoid overcrowding on these systems, proposed solutions include shifting buses to "drop off only" when buses are at capacity, sending ambassadors to transit stops to discourage non-essential trips, and adjusting routes to increase service during shift changes at high ridership stops.

San Diego MTS forced to shelve local transit funding measure

- San Diego MTS is the latest in a string of public transit agencies opting to delay proposed local sales tax measures due to the fallout from the coronavirus.
- MTS's measure would have increased trolley and bus frequency, created rapid transit routes, and supported free transit passes for youths.
- MTS will reconsider the measure in the future.
