

Transit Watch: **Public Transit in Crisis**

Friends.

Significant ridership and fare revenue declines buffet public transit agencies due to the coronavirus pandemic, as most Californians responsibly shelter in place; these fiscal impacts today threaten the viability and availability of transit services in the near- and long-term.

Keeping public transit services available and sustainable during this time of crisis should continue to be a local, state and federal priority, as public transportation systems still carry many essential service workers to and from their jobs.

The recently signed federal relief package (CARES Act) provides much needed immediate funding for local transit agencies, and will help mitigate the worst impacts of COVID-19 in the near-term. However, while federal assistance addresses the immediate crisis, additional funding may be needed over the long-term to prevent permanent, significant cuts to transit.

A robust network of transit systems will also be critical to helping our economy get back on track when life returns to normal, by getting millions of people to work, school, shopping, medical appointments and other obligations - as was happening before the pandemic hit.

Restoring viable public transit will also be essential if we're going to continue to make progress toward our greenhouse gas reduction and clean air goals, while also creating a more equitable society that provides mobility options for seniors, working-class and lower-income families

California Transit Association responds to federal stimulus package

- The CARES Act provides more than \$25 billion to public transit agencies nationally, with more than \$3.74 billion dedicated to California's transit agencies.
- The California Transit Association issued a statement in response to the federal coronavirus relief bill, known as the CARES Act.

SF Muni Suspends Nearly All Routes

- As the result of COVID-19 impacts, Muni Metro, San Francisco's subway, bus and light rail service shut down all service except for 17 "core" routes.
- Muni also anticipates that 40% of their operators will be out due to complications of COVID-19.
- In spite of these challenges, Muni continues transporting more than 100,000 riders daily getting nurses, cooks, custodians, and other essential workers to their jobs.

Southern California transit agencies go fare free to help protect public and staff

- Several Southern California transit agencies, including LA Metro, Foothill Transit, Santa Monica's Big Blue Bus, Omnitrans and Antelope Valley Transit Authority, have temporarily eliminated fares on buses to help keep the public and their drivers safe.
- By moving to rear-entrance boarding only and relaxing requirements to pay fares, riders abide by the CDC's social-distancing recommendations.

Sacramento Regional Transit ridership down sharply due to shutdown

- California's capital transit agency is experiencing a ridership decline of more than 75% due to the coronavirus pandemic.
- It has reduced services to just 38% of normal daily routes, subject to increase based on demand. la Grants for Rural Areas: \$86,790,829
